

## **JULIANI LAB SALES REPRESENTATIVE AGREEMENT**

This Agreement is made between Juliani Lab (“the Company”) and the undersigned individual (“the Sales Representative”) for the purpose of promoting and selling Juliani Lab products and services.

### **1. Products**

The Sales Representative will promote and sell the following products on behalf of Juliani Lab:

Juliani Jems – Subscription for Juliani fans (KES 10,900).

Juliani Access – Corporate partnership subscription (KES 980,000).

### **2. Commission Structure**

The Sales Representative shall earn a commission of 8% on each successful sale.

For three (3) or more sales within a sales cycle, the commission shall increase to 10% per sale.

Commissions are payable within 14 working days after the Company receives full payment for the sale.

### **3. Responsibilities of the Sales Representative**

The Sales Representative agrees to:

Represent the Juliani Lab brand professionally and honestly at all times.

Use only official sales materials and approved information when presenting Juliani Lab products.

Submit accurate sales records using the assigned sales code or referral link.

Refrain from making false claims, misrepresentations, or unauthorized promises about the Company or its products.

#### 4. Non-Employment Clause

The Sales Representative is an independent contractor, not an employee of Juliani Lab.

No employment benefits (e.g., salary, insurance, leave) shall apply.

The Sales Representative is responsible for managing their own taxes and compliance with applicable laws.

#### 5. Confidentiality

The Sales Representative agrees to keep all company information, customer data, and internal communications strictly confidential, and shall not share them with third parties without written consent.

#### 6. Termination

Juliani Lab reserves the right to terminate this agreement at any time if:

The Sales Representative engages in misconduct or brand misrepresentation;

Fails to deliver within agreed ethical or performance standards; or

Violates any of the terms outlined herein.

Upon termination, all pending commissions for verified sales will be settled, and the Sales Representative must cease using the Juliani Lab name, logo, or materials immediately.
